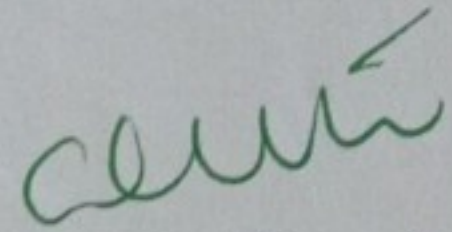
Accordingly the Gender Harassment Committee has been re-constituted as specified below:
